4. FIRST-AID MEASURES

- If inhaled : No treatment necessary under normal conditions of use.
If symptoms persist, obtain medical advice.
- In case of skin contact : Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available.
If persistent irritation occurs, obtain medical attention.
- When using high pressure equipment, injection of product under the skin can occur. If high pressure injuries occur, the casualty should be sent immediately to a hospital. Do not wait for symptoms to develop.
Obtain medical attention even in the absence of apparent wounds.

- Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection.

- High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function.

Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Engineering measures

Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material. Glove thickness should be typically greater than 0.35 mm depending on the glove make and model.
